This Indenture made the twelfth day of December in the Year of our Lord one thousand seven hundred and eighty three Between John Cochran of Frederick County and State of Maryland Practitioner of Physick of the one part And John Beagayn, Cordwinder of the same County and Steate aforesaid of the other part Witnesseth that the said John Cochran for and in consideration of the Sum of five pounds Current Gold and Silver Money to him in Hand paid by the said John Beagayn the Receipt whereof the said John Cochran doth hereby acknowledge, and for and in consideration of the Yearly Rent of Spanish Milled Dollar to be paid to the said John Cochran his Heirs Executors Administrators or Assigns, on the twenty second day of June yearly and every Year forever hath given granted bargained sold aliened releast and confirmed, and by these Presents doth give grant bargain sell alien release and confirm unto him the said John Beagayn his Heirs and Assigns forever: All his the said John Cochran Right Title Interest and Property of in and to all the following Lott of Ground in the Town of Liberty in Frederick County aforesaid, on a Draught of Linganore call'd Piney Run, being Part of a Tract of Land called Dukes Woods the said Lott being Number Sixty four. Beginning at a Stake marked Number 63. standing on the North Side of the Main Street in the Town of Liberty, and running thence North four degrees, West three hundred Feet. Then South
